Meals are available to organizations that are hosting a group of children, 18 and younger for summer activities thru the Summer Food Service Program offered by Patrick County school nutrition programs for the month of June.

Patrick County school nutrition program will sponsor free meals for children living in Patrick County to the host organizations. Organizations hosting Bible schools, sports or activity “camps,” boys and girls clubs, day cares and any other organized activities for 3 or more days for local youth aged 18 year and under are encouraged to call for more information.

Foods available includes breakfast, lunch, supper and snack. Meals will be provided to all children free of charge and are the same for all children regardless of race, color, national origin, sex, age or disability. There will be no discrimination in the course of the meal service. You will not be ask for verification of any income.

There will be a mandatory training session for all who participate in the Summer Food Service Program. You will need to have a representative from you organization attend this meeting.
