No. 25634 Public Comment

Ms. Raina Brim, speaking on behalf of the Patrick County Friends for Equity and Justice requested the following:

That the Patrick County School Board should establish an Anti-Racism Policy for Students and Employees that should include the following:

- 1. The banning of the Confederate (Rebel) Flag apparel and paraphernalia in all school buildings and on all school grounds.
- 2. The banning of racist language.
- 3. Addressing micro-aggressions (subtle, often unintentional, form of prejudice. Rather than an overt declaration of racism or sexism, a microaggression often takes the shape of an offhanded comment, an inadvertently painful joke, or a pointed insult.) and racially insensitive comments or actions.
- 4. Straightforward consequences for violating the above items.
 - a. Awareness Conference/Training/Workshop some type of diversity awareness training.

We believe these items should not be included in Bullying, Dress Code, or Vulgar Language Policies, but included in a separate Anti-Racism Policy.

a. October Calendar adjustments

Superintendent Gilbert informed the school board of the necessary October Calendar Adjustments as follows:

- 10/13 End of 1st nine weeks / Regular School Day (Scheduled as an early dismissal)
- 10/14 Regular Virtual Wednesday
- 10/21 Regular Virtual Wednesday/Conference Day Virtual & In-person by appointment
- 10/22 Regular School Day (Scheduled as an early dismissal day)
- b. Diversity and Equity Committee

Mr. Tony Mosley, Teacher at PCHS, reported on the Patrick County Diversity and Equity Committee which has been meeting since July to discuss ways to better support all PCHS Students. Requesting that school board consider these four (4) recommendations:

- 1. Special Education Students and English Language Students need the opportunity to attend school four days a week to ensure they are receiving the necessary accommodations and closing the achievement gap.
- 2. To obtain information about diversity, perceptions of treatment of ethnic groups and minorities, and the perception of confederate apparel, a student survey in grades 6-12 should be conducted.
- 3. Prohibiting confederate apparel should be added to the dress code.
- 4. The name and/or the depiction of the Hardin Reynolds Rebels mascot should be changed.

Mr. Mosley also included the positives for PCHS:

- A. PCPS is one of the 5 School Divisions in VA that does not show a discrepancy in suspensions of minorities. Only 5 out of 132 school divisions can say that and PCPS is one of them.
- B. SROs in Patrick County, 94% of the 6-12 students report that they feel safer due to our school resource officers. This is higher than the state average of 85%.
- C. Teacher/Staff Working Conditions Survey show our staff satisfaction is higher than the state average in all areas. PCPS is truly a great place to work!!!
- D. Student Climate Survey. Students report a higher than average Sense of Belonging in our schools and a low perception of being mistreated by staff members.

c. Superintendent's Report

- 1. Covid 19 quarantines and positive cases. (None of the positive cases have been traced back to the school setting.)
- 2. Meal pick-up system still in place.
- 3. Custodians are sanitizing buses on a daily basis.
- 4. Bus drivers are sanitizing buses between the morning and afternoon routes.
- 5. Offer option of four days a week to Special Education and English Language Learners beginning Monday, October 12, 2020.
